

MODIFIED VEHICLES AGREEMENT AND ADDENDUM TO TERMS AND CONDITIONS OF STANDARD RENTAL AGREEMENT*

These Additional Terms supplement, and is in addition to, the Terms and Conditions of Standard Rental Agreement (hereinafter 'the Rental Agreement') between You and Us. These Additional Terms and the Rental Agreement together constitute the agreement between You and Us for the rental of a vehicle that is fitted with activated hand controls (Modified Vehicle).

At time of pick-up, you will be required to declare that the following statements are true and correct:

- (a) You have inspected the Modified Vehicle and the type of hand controls that have been fitted to the Modified Vehicle;
- (b) You (and any Authorised Driver) have obtained advice and confirmation from an appropriate health professional that the type of Modified Vehicle, and the type of hand controls that have been fitted to the Modified Vehicle, are suitable for Your (or any Authorised Driver's) specific abilities;
- (c) You (and any Authorised Driver) can competently and safely operate the Modified Vehicle with the type of hand controls that have been fitted; and
- (d) You (and any Authorised Driver) have a driver's licence that allows You (or any Authorised Driver) to drive the Modified Vehicle with the type of hand controls that have been fitted.

Requirements: You and any Authorised Driver must meet the conditions, or any other requirements (if any) imposed on Your licence (or any Authorised Driver's licence), when driving the Modified Vehicle.

You agree that if any of the Declarations are false or misleading, or if You or any Authorised Driver don't meet the Requirements, it will be deemed a Prohibited Use and/or a material breach of the Rental Agreement.

You and any Authorised Driver will not have the benefit of the Loss and Damage Waiver option or Excess Reduction option (if accepted or included in Your Rental Agreement) if any of the Declarations are false or misleading or if You or an Authorised Driver don't meet the Requirements.

Example: If the Prohibited Use or breach of the Rental Agreement caused, or contributed to, loss or damage to the Modified Vehicle or to any third party, We may exercise all rights pursuant to the Rental Agreement, including termination of the Rental Agreement and the recovery of any loss or damage suffered by Us (or on behalf of any third party) as set out in the 'Liability for Loss or Damage' section of the Rental Agreement.

In this document, the terms "We" (or "Us"), "You" (or "Your"), "Prohibited Use", "Loss and Damage Waiver", "Rental Period", "Excess Reduction" and "Authorised Driver" have the meaning as set out in the Rental Agreement.

*These Additional Terms & Conditions do not apply to vehicles that are not fitted with hand controls or vehicles in which the hand controls are de-activated or not in use.
